## Publication Agreement

This agreement between \_\_\_\_\_ (“you”) and the College Art Association (“CAA”) sets forth the terms and conditions in connection with the publication of your article, entitled “\_\_\_\_\_” (the “Contribution”), and with the unpublished version of your article (the “Author’s Original Manuscript”), which has been accepted for publication in *The Art Bulletin* (the “Publication”).

1. You hereby grant a perpetual, worldwide, royalty-free, paid-up license to CAA to (i) reproduce, distribute and publish the Contribution as part of the Publication, which rights include the right of CAA, any of its affiliates and any of its or their licensees to reproduce, distribute and publish the Contribution as part of the Publication in any and all forms or media, whether now known or as may hereafter be developed, including, but not limited to, hard copy, electronic databases, microfilm, online services, World Wide Web sites, CD-ROMs, whether published or distributed by CAA or by third-party licensees of CAA, and whether or not your Contribution may be individually accessed, perceived or retrieved apart from the Publication and (ii) to license the reproduction, distribution and publication of the Contribution for limited non-profit educational uses, such as course-packs, access-restricted academic intranet course offerings and similar compilations of academic materials, in any and all forms or media, whether now known or as may hereafter be developed. You further agree that CAA has the right of first publication of the Contribution throughout the world in any language, and that upon first publication by CAA of the Contribution in the Publication, in any form or media, you have the right to republish thereafter your Contribution in a publication that is not competitive with the Publication, provided that prior to such republication you first obtain the consent of CAA, which consent will not unreasonably be withheld. Except as set out in this Paragraph 1, you retain, without obtaining the consent of CAA, the right to share on a non-commercial basis with colleagues in print or digital format your “Author’s Original Manuscript” (i.e., the unpublished version of the article created by you prior to peer review; formerly a “preprint”); the right to post on a non-commercial basis your “Author’s Original Manuscript” as a digital file on your own website for personal or professional use, or on your institution’s network or intranet or website, or in a subject repository that does not offer content for commercial sale or for any systematic external distribution by a third party, provided that you do not use the PDF version of the article prepared by us and that you include any amendments or deletions or warnings relating to the article issued or published by us; and only with this acknowledgement: “This is an Author’s Original Manuscript of an article published in [include the complete citation information for the final version of the article as published in *The Art Bulletin* with date of publication] [© copyright the College Art Association], available online at: [http://www.tandfonline.com/\[Article DOI\]](http://www.tandfonline.com/[Article DOI]).”

2. You represent and warrant that (a) you are the sole creator of the Contribution; (b) the Contribution is original and has not previously been published by you or any other person in any other form; (c) the Contribution does not defame any person or unlawfully invade his or her privacy; and (d) subject to Paragraph 3, that the reproduction, publication or distribution of the Contribution will not infringe upon or misappropriate the proprietary rights of any third party.

3. CAA requires that you determine, prior to CAA's publication, whether it is necessary to obtain permissions from all third parties who own rights in any photographs, illustrations, drawings, text or any other material ("third-party work") to be published with or in connection with your Contribution. In making that determination, please refer to the "Addendum: Invoking Fair Use to Publish Third-Party Materials—Analytic Writing" and to the *Code of Best Practices in Fair Use for the Visual Arts*, available at [www.collegeart.org/fair-use](http://www.collegeart.org/fair-use). For each third-party work, you must determine, in accordance with the Addendum and the Code, whether the use thereof in your Contribution is a fair use under U.S. copyright law. If you determine that such use is a fair use, you need not obtain permissions from the third party who owns the U.S. copyright rights in the third-party work and your representation (in Paragraph 2(d)) that the reproduction, publication or distribution of the Contribution will not infringe the proprietary rights of any third party will not include copyright rights. If, however, there are proprietary or private rights in the third-party work other than copyright, or if you determine that your use is not a fair use under U.S. copyright law, then you represent and warrant that you have obtained all such rights that are necessary to reproduce, publish or distribute such third-party works in the Contribution, whether in any hard copy, electronic or other form or media, and whether or not your Contribution or such third-party work may be individually accessed, perceived or retrieved apart from the Publication, as set out in Paragraph 1. In addition, prior to publication of the Contribution, where you are required by the foregoing to obtain permissions, you agree to supply copies of signed permissions or other clearances, in a form satisfactory to CAA, from the rights holder of each third-party work.

4. You agree unconditionally to release, and to indemnify and hold harmless, CAA, its affiliates and its and their licensees, and its and their agents, representatives and assignees from and against any and all liability, claims and costs, including losses, expenses and reasonable attorney's fees and expenses, that it or they incur as a result of any breach by you of any of the foregoing representations and warranties, including, but not limited to, liability, claims and costs arising out of any claims by third parties with regard to the publication of third-party works with or in connection with the Contribution, in any form or media. You do not have to indemnify CAA for any third-party claims of copyright infringement with respect to third-party works for which you have determined your use is a fair use in accordance with Paragraph 3.

5. Upon publication of the Contribution in *The Art Bulletin*, you will be provided with two complimentary copies of the issue of the Publication in which the Contribution appears. You may purchase copies of such issue at the CAA member price. You will also be provided with 49 digital offprints.

6. You shall submit the Contribution and any third-party works on or before the date requested. The Contribution shall conform to the Guidelines for Authors published on the CAA website, at [www.collegeart.org/artbulletin/guidelines.html](http://www.collegeart.org/artbulletin/guidelines.html). You agree to answer the manuscript editor's queries. You agree to read, correct and respond promptly to all typesetters' queries. You agree to supply documentation of permissions clearance for all third-party materials (such as images or quoted text). You understand that failure to adhere to the schedule provided to you for review of the edited Contribution and proofs may cause the Contribution to be withdrawn from Publication.

7. This agreement shall be governed by and construed in accordance with the laws of the State of New York applicable to agreements made entirely within the state. This agreement contains the complete agreement and understanding between the parties and supersedes all prior or contemporaneous discussions or agreements between you and CAA regarding the submission of the Contribution. It may not be modified either orally or in writing by any employee of CAA. The parties hereby consent to the jurisdiction and venue in any federal or state court of competent jurisdiction located in the State of New York for the adjudication of any disputes under this agreement.

8. By signing this agreement, you certify that you have complied with the requirements of Paragraph 3 with respect to determining that your use of third-party works in the Contribution is a fair use under U.S. copyright law.

## **Addendum: Invoking Fair Use to Publish Third-Party Materials—Analytic Writing**

CAA will not require that you obtain permissions for the use of images and other third-party works in your Contribution if you determine, in good faith, that your use of such third-party works is a fair use under U.S. copyright law. In making that determination, you should review the PDF of CAA's *Code of Best Practices in Fair Use for the Visual Arts*, which was sent to you when your Contribution was accepted for publication. For discussion of the fair use doctrine of U.S. copyright law, please see pp. 14–17 of the Code. Fair use can be applied only to images and other third-party materials to which the user has access. Sometimes, however, permission must be sought because a sole source controls an object or image of it, even when the underlying work itself is in the public domain. Because demands for permission fees in this context are not based on copyright, fair use cannot be invoked to avoid paying such fees.

Works in the public domain may be used without obtaining permissions. Even if the work itself is in the public domain, however, photographers of three-dimensional artworks (such as sculpture, architecture, or performance) or the organizations that employ them may hold rights in their photographs.

The Code provides that in analytic writing about art, scholars may invoke fair use to quote, excerpt, or reproduce copyrighted works, subject to certain limitations. For a summary of the limitations, see pp. 9–10 of the Code.

To aid you in making a determination as to whether your use of third-party works is a fair use, CAA suggests that you consider the following questions. These are not, however, a substitute for the requirement that you review the Code and the Frequently Asked Questions.

Does the analytic objective of your text justify your use of the third-party work? Can you articulate the justification?

Does your analytic objective predominate over that of merely representing the third-party work or works used? Does use of the material with your text provide new insights and understandings into the subject of your contribution?

Does the amount and kind of material used or (where images are concerned) the size and resolution of the published reproduction exceed that appropriate to the analytic objective?

Are you reproducing born-digital works in digital-format reproductions? If so, can you justify use and amount used where there is a heightened risk that reproductions may function as substitutes for the originals?

Does the reproduction of the work accurately represent the original work?

Does the text or ancillary material (title, captions, and so forth) give the attribution of the original work?
